1. A minimum 25% non-refundable retainer fee is required at time of booking to guarantee our availability on your date. The remaining balance is due 7 days prior to the wedding ceremony. Failure to pay the full balance prior to the event will cancel the booking and forfeit the retainer fee.
2. Retainer fees are not refundable.
3. Any footage to be emphasized or omitted must be expressed to the video crew during time of shooting and in writing within 3 days after ceremony (email is acceptable). KR Productions will exercise best efforts to film and edit the footage as professionally as possible under contracted terms.
4. All videos and images are subject to be used as a demo (provided on DVD, online, or other format) and you agree to be used as a reference.
5. KR Productions makes no guarantees, either expressed or implied, in regard to the aesthetic or stylistic qualities of the completed video.
6. Delivery times vary. Videos normally are delivered within 6-10 weeks following the event.
7. KR Productions uses existing light for all footage. KR Productions will not be responsible for dark video footage due to dim lighting conditions at the location of wedding events.
8. The wedding party, prior to the ceremony, must verify permission to film on location. KR Productions will not be responsible for unwanted shooting angles due to venue rules.
9. KR Productions must be provided, in typed print, all names that will be in the video credits prior to the wedding ceremony. KR Productions is only responsible for the proper spelling of the material given. If the list of names given contains spelling errors, KR Productions will only correct the errors for the editing rate of \$50.00 per ½ hour.
10. Any edits of final product due to error of KR Productions will be done free of charge. Any edits of final product not due to error of KR Productions will be done at a rate of \$50.00 per ½ hour.
11. Edited footage may be reduced such that it is not shown in real time.
12. There is a possibility of camera failure and loss of footage leading to an incomplete video. In case of such failure, KR Productions will use best efforts to edit the video.
13. KR Productions takes utmost care with respect to the exposure, editing, duplication, and delivery of the video products and services offered. However, in the event that either party to this Agreement fails to comply with the terms of this Agreement, liability is limited to the refund of the total value of this Agreement, less the retainer fee.
14. If any provision of this Agreement is held unenforceable, then such provision will be modified to reflect the parties' intention. All remaining provisions of this Agreement shall remain in full force and effect.
15. In the event of litigation relating to the subject matter of this Agreement, the non-prevailing party shall reimburse the prevailing party for all reasonable attorney fees and any resulting costs.
16. KR Productions's principal place of business is in Decatur, Alabama. This agreement shall be interpreted under the laws of the State of Alabama.
17. This Agreement and the exhibits attached hereto contain the entire agreement of the parties with respect to the subject matter of this Agreement, and supersede all prior negotiations, agreements and understandings. This Agreement may only be amended by a written document duly executed by all parties.
18. I understand that even with careful planning and prior discussion about wedding event details, there is the possibility of an issue arising during filming such as the camera crew not being able to shoot good video footage, interference with the wireless microphones, and similar issues. I understand that KR Productions will work to correct the problem in an unobtrusive manner, however if the problem can not be resolved, I have informed my wedding party, the officiates of the ceremony, the director, and the photographer that KR Productions has the authority to stop the wedding ceremony to correct the problem.
19. I understand that if I am purchasing a package with unedited video, that I will be receiving the raw footage on DVD without any clean up or editing.
20. I understand that for events with single camera coverage, there is a possibility that not all happenings at the event will be captured on tape. Likewise, there is no guarantee that all happenings will be covered with multi-camera options.
